4. Details of our assessment

On Friday the 2nd of June 2023 Natural Resources Wales officers carried out an announced site inspection.

The weather was hot and dry.

The purpose of the visit was to check compliance and to introduce the new regulating officer for the site, Ian Thomas.

Officers were met by one of the site operatives who showed them around the site.

The outdoor storage area appeared busy with substantial amount of waste being stored at the back of the yard.

WEEE storage bay

Officers were shown a dedicated bay for all waste electronic and electrical equipment – WEEE.

The bay is being used as part of an ongoing contract for temporary storage before the waste being collected for onward transport and treatment.

Officers noted a few WEEE in the main scrap metal pile. Please see the below photos.

Condition 2.4.2 states

The storage (including temporary storage) and treatment of WEEE shall be carried out in accordance with the technical requirements of Annex III of the WEEE Directive.

Action: Please ensure all WEEE is kept separate ready for collection. For immediate compliance.
