4. Details of our assessment

This report details the site visit made on the 24 May 2023 to United Recycling Aggregates LTD, permit reference number EPR-PB3230AQ. Officers Carla CURTIS and Chris BURGE attended the United Recycling Aggregates LTD site at Birdport Docks, Newport, NP19 4RE for a routine site inspection at 10:00, I arranged to meet Daniel KINCH, Recycling manager on site but the gates were locked. I was able to carry out the inspection through the gates. The weather was warm and sunny which it had been the previous day.

GENERAL OBSERVATIONS

The site is primarily used as a storage area for small amounts of waste material such as aggregates. At the time of the visit there were several stockpiles of aggregate material (as seen in photos 1 and 2)

General housekeeping on the site was of a good standard, the infrastructure on site appeared to be in good order with no cause for concern.
