4. Details of our assessment

Watpol received. Issues with BW3202501 CSO asset Bettws Road CSO Llangeinor spilling in dry weather.

Not able to complete action below in time for previous CAR (CAR_NRW0039940) deadline (18.07.2022), so issuing a further CAR to extend the deadline to April 2023. Last section now. Approximately 0.5miles left after completing 2miles of surveying and removing roots and other debris.

Action from last CAR:

remove blockage to ensure hydraulic capacity as per permit requirements. Survey line for any infrastructure problems and feedback findings. Deadline of 2 months given to ensure low levels for surveying.

Action for current CAR:

Ensure no physical restriction on the network which may cause CSO to spill.

Amended this CAR on 08.06.2023:

Following e-mail from Pollution Tech Dan Foreman, extended deadline to the end of summer to allow Capital team to complete works.

E-mail request included below:

Could this CAR form be extended a couple more months please. Due to the high flows over the winter months we was unable to manage the flows to complete the CCTV works in the time frame. We did jetting works that had some minor effect on the operation of the network but still not operating to its potential. Investigations have now been passed to our capital team to deliver. We are also currently in the process of looking at additional options that

include Sonar survey.
