4. Details of our assessment

Biffa Trecatti Landfill

Permit RP3733PC

NRW site inspection 2nd June 2023

Present; Simon Milford (Site Manager), Rose Mcegan (Biffa Environmental Control advisor). Richard Taylor (NRW Site Inspector)

This was a routine site inspection which focussed upon the effluent treatment plant and surface water discharge.

NRW currently have a limitation in place which does not allow a site inspection to commence in areas which could have high levels of gas present such as the landfill gas engines area. The tipping face was also avoided until NRW policy around personal gas alarms is resolved.

Effluent treatment plant

The water sampling and treatment processes were talked through. All site leachate and effluent can be pumped to the treatment plant which has a 2-day holding capacity approx. All site effluent comes through the ETP. Releases of treated effluent conform to permit limits.

Surface water outfall

The process on site was discussed. Surface water can be diverted to the ETP if necessary. Samples are taken routinely but often dry at the outflow as was seen on the day. The area is well maintained with good access for the sampling staff.

Site Lab

This is used for check analysis for samples taken on site and is not accredited to any recognised standard. The lab has a dedicated storage fridge but no formal temperature measurement which is necessary for compliance with NRW M18 guidance. At section 5.5 a temperature of 5°C (+/- 3° is required to store samples prior to collection. Site are encouraged to audit the courier collection periodically to ensure that the temperature of site sampled remains within range. This is so that the samples are not invalidated through exposure to high/low temperatures.

Recommendation – Site to install a thermometer in the dedicated lab fridge to ensure the temperature of the samples remains within M18 guidance range.

Other Observations

The site was open for business and operating at the time. There was no observed windblown waste on the perimeter fences, no odour, no excessive dust, or noise seen. Bird presence was minimal. There were no invasive weeds or pests seen. The site was relatively clean and well managed.
