4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) findings following an inspection of stored waste in response to complaints relating to fly proliferation in the locality of the operation.

Beginning on 12 June 2023, Natural Resources Wales received a number of complaints in relation to fly proliferation in the locality of GLJ Recycling Limited, with some complainers suggesting that the operations being undertaken at GLJ Recycling Limited were the source of the flies. The Local Authority also received complaints in relation to fly proliferation in Cwmcarn village.

Condition 3.6.1 of the environmental permit states:

The activities shall not give rise to the presence of pests which are likely to cause pollution, hazard or annoyance outside the boundary of the site. The operator shall not be taken to have breached this condition if appropriate measures, including, but not limited to, those specified in any approved pests management plan, have been taken to prevent or where that is not practicable, to minimise the presence of pests on the site.

The operator has not instated a specific pest management plan and nor was one requested to be instated as part of the original permit application determination process.

On 15 June 2023, an inspection of the operation was undertaken in response to the complaints. The inspection involved a visual examination of all waste stock piles across the site for evidence of flies or fly larvae/pupae.

A small number of flies (<30) were observed in the vicinity of some baled waste cans towards the northern limit of the operations (photograph 1 and 2). A small number of flies (<30) were also observed in the vicinity of the bulky waste storage area.

No other fly clusters or fly larvae/pupae were observed on the premises.

We observed no evidence that the waste storage and treatment activities being carried out within the permitted boundary is attracting pests, allowing pests to breed and/or disperse from the operation.
