Analysis of the sample demonstrated condition 3.1.2, limits given in schedule 3, had been breached:

The discharge shall contain no more than 30 mg/l of suspended solids. The sample result provided a results of 31.5 mg/l

The discharge shall contain no more than 5.45 mg/l of Ammoniacal Nitrogen. The sample result provided a result of 39.5 mg/l
