BRIEF DESCRIPTION OF INCIDENT Operators onsite at Aberbaiden SWK identified a drop off of PFF entering the inlet flume and it was spilling over the storm weir to the storm tanks. Site operator escalated this issue to the area Instrument Technician as they were concerned there was an issue with the flow meter reading incorrectly. The flow meter was determined to be working and then inlet penstock was opened fully in hand; there was no increase in forward flow. It was now determined that there was an obstruction in the inlet restricting forward flow to the treatment works. A crew attended site and jetted the inlet pipework removing rag and silt from the flum, it is likely this had built up from the recent wet weather conditions. This works restored forward flow and the treatment works is back to normal operation.
