4. Details of our assessment

The main purpose of the Tarmac Trading Limited (Tarmac) activities at the Port Talbot installation are to serve the Tata Steel UK Limited (TSUK) steelworks processes (EPR/ BL7108IM).

These activities are directly associated with iron and steel production and include slag handling and granulation. Tarmac granulates, crushes and screens slag from the blast furnaces and weathers, crushes and screens de-metalled slag from the steel (Basic Oxygen Steel) plant.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

Compliance Assessment

1. 2022 Annual Returns

The operator is required to submit an annual report on the performance of the activities over the previous year by the 31st January as per condition 4.2.3. Tarmac submitted their annual report on the 31st January 2023; in line with the permit requirements.

The annual submission consisted of the following documents:

- Form Performance 1 (02/03/16)
- Form Air 1 (02/03/16)
- Form Particulate 1 (02/03/16)

The annual submission contained the required information in accordance with permit condition 4.2.3.

Granulation rates were consistent with previous years; with approximately 80% of the total liquid slag granulated.

A1 – BF4 Granulation Plant

Spot extractive sampling was undertaken on the 7th November 2022 in accordance with permit condition 3.5.1. No exceedances of the SO₂, H₂S or PM emission limits were noted.

A5 – BF5 Granulation Plant

Spot extractive sampling was undertaken on the 16th December 2022 in accordance with permit condition 3.5.1. No exceedances of the SO₂, H₂S or PM emission limits were noted.

2. Q1 2023 Monitoring Returns

Tarmac submitted the Q1 2023 monitoring returns on the 6th April 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.2).

The required operational parameters were submitted including Cooling Water pH and Blast Furnace Slag figures. Granulation rates were consistent with previous monitoring periods; with approximately 79.89% of the liquid slag granulated.
