4. Details of our assessment

This compliance report details the inspection conducted by Natural Resources Wales (NRW) Officers on Tuesday 14th of March 2023 at SL Recycling Limited, Unit 1, Pontyfelin Industrial Estate, Pontypool, NP4 0DQ - Permit number **EPR - BB3299FN**.

Hazardous regulation officer Alex TENNANT and Tackling waste crime officer Mark OUGHTON attended SL Recycling Limited to conduct a standard inspection.

Site manager & TCM Becky Tucker was present on site, and accompanied officers around the permitted boundary. Weather conditions were mild and sunny at the time of inspection.

All previous inspection compliance actions completed.

GENERAL OBSERVATIONS AND WASTE ACTIVITIES

Officers entered the site and signed into the office diary. An update was given by Becky regarding the site operation and a general discussion about the site activities since the last inspection. Officers touched on the noise complaints received by NRW during February and any mitigation measures that had been added to site since then.

No deflagrations have occurred on the site since the last inspection in February.

There was improvement seen compared with the previous site inspection and engagement was high from operator to offer a tour of site to interested community parties to display the improvements that have been made.

METAL RECYCLING

The acoustic wall that was in construction at the last time of inspection has now been completed - which is approximately 6 metres high.

Stock piles height have noticeably reduced since last inspection but reminder given to keep them at 4m height and follow operators routine waste management procedures, which were compliant at time of inspection.



METAL SHREDDER AND DEFLAGRATIONS

The metal shredder was not in operation at the time of visit. The operator explained method for accepting waste onto site and reducing the risk of deflagration events. The operator should continue to conduct strict segregation methods and pre-treatment activities to ensure that any risk materials are identified at the earliest stage.

The operator confirmed that warning letters are issued to any clients that breach their policy.



WASTE RETURNS

Non - hazardous waste tickets were not inspected during the visit.

No condition breaches were scored against the permit on this inspection.
