4. Details of our assessment

This compliance report details the site inspection conducted by Natural Resources Wales (NRW) on the 20th of June at S L Recycling Limited, Penallta Industrial Estate, Hengoed, CF82 7SU - Permit number PAN - 016333 V002.

Hazardous Waste Officer Alex TENNANT attended SL Recycling at 1500hrs to conduct an inspection following a WIRS report of an explosion received on site on the 13th of June.

BACKGROUND

S L Recycling submitted an application on the 13th of Decemebr 2021 to vary their environmental permit BB3299FN from two standard rules permits SR2012 No 14: Metal recycling, vehicle storage, de-pollution and dismantling (authorised treatment) facility and SR2008 N0 3: Household commercial industrial waste transfer station and treatment (building) to a bespoke permit, which would allow them to undertake the same activities with the addition of metal shredding outside. Permit assessment focused on the environmental management plan summary, fire prevention and mitigation plan, noise impact assessment, odour management plan and dust management plan. On the 16th of June the permit variation was issued to SL Recycling. Issuing of the permit does not negate the need for any other consents required by SL Recycling Limited to operate the facility, make changes to or erect the infrastructure needed to manage the environmental risks from the site e.g. the acoustic barrier.

SL Recycling is currently in the midst of an ongoing planning appeal with the hearing heard on the 16th of May. The operator is expecting to hear this week the result of that appeal.

Pre shredder

Operation confirmed that the pre shredder is not in operation under the result of the planning appeal has been determined. Since the last site inspection there have been two reports of deflagration events - operator confirmed that any incidents will be greater reduced with the operation of the pre shredder.

Metal Shredder

The metal shredder was not in operation at the time of the visit.

**ACTION**

Please could the operator send the past 10 consignment notes for completed waste acceptance at the New Inn site by 10th August 2023.

No condition breaches were scored against this permit.
