4. Details of our assessment

At 13:00 on the 9th June 2023 and unannounced site inspection was undertaken by NRW officer Phil Harper (Senior Industry & Waste Regulation).

The site was operational at the time of the inspection.

At the time of the inspection the facility was in a clean and well-maintained condition.

IR3B Emissions of Substances not Controlled by Emissions Limits

Outdoor storage areas for raw materials and waste were inspected. Outside impermeable areas had been cleaned. Damage to the french drain adjacent to the acid storage tanks could be observed. It is understood that repairs were completed to a section of the French drain, however, it failed due to winter and heavy vehicles driving over it.

The operator has concluded that the drain channels need to be replaced to ensure a more robust fix. This work will be completed before the end of August 2023.

Plans have been submitted by the operator to improve secondary containment around the bulk hydrochloric acid (HCl) tank as required by CAR_NRW0040313 which was issued to the operator on the 8th September 2023. The plans indicate that the improvements will be made to the containment around the tank in quarter 3 2023.

Action: Complete improvements to the containment around the HCl tank by the 1st October 2023.

Raw materials, waste and products were segregated on the site. Bulk containers were stored on racking systems which were positioned within the bunded area. All containers were positioned over the bunded area.
