4. Details of our assessment

On the 2nd of June 2023, a routine unannounced site inspection was conducted at H K Motors, Ruabon, by Natural Resources Wales waste regulation officers.

The site was last inspected on the 16th of June 2021. Compliance assessment for CAR_NRW0038461 refers.

The purpose of the visit was to check compliance and to introduce the new regulating officer Ian Thomas.

The weather was hot and dry.

The site manager, Ian Williams, and Keith Williams were present for part of the inspection.

General Management

The site was tidy with End-of-life vehicles stored in rows, or stacks of up to four.

Some vehicles were stored on the grass verge.

Officers checked several vehicles and they had been depolluted.

The depollution area was checked, all hazardous fluids and batteries were stored within the correct containers.

Documentation

Whilst on site officers asked to see the permit. Mr Williams stated that it is being kept in the main office.
