4. Details of our assessment

On the 29th May 2023 Environment Officer Nathan Owen attended an incident at Bethesda STW following a report alleging that there was grey effluent visible from the final effluent outfall. Nathan was accompanied on site by DCWW Pollution Technician Gareth Williams.

An OPNOT was sent to NRW at 15:47 stating that the generator powering the temporary aerator had failed and had resulted in slight deterioration in the final effluent. Due to a technical error this notification was not received by NRW until 21:04.

A sample was taken and analysed by NRW and showed a BOD of 32mg/l which is elevated from the 25mg/l limit however within the 60mg/l upper tier limit as stated on the permit. The

Ammonia showed a result of 22.7mg/l which is within the upper tier limit of 48mg/l. Despite the issues notified by DCWW, the quality of final effluent discharged was meeting its consented limits.
