CQA Proposal – Phase I Cell 13 Additional Sump and Surface Water Drainage Revision – Record of Acceptance

The permit (condition 2.6.5) requires the operator to submit construction proposals, prior to the construction of any landfill infrastructure. Construction should not commence until Natural Resources Wales (NRW) has confirmed that it is satisfied with the construction proposals.

The operator has submitted construction proposals for the installation of additional leachate extraction infrastructure, rerouting of surface water drainage and modifications to the ground levels on Phase 1 Cell 13. The construction proposals consist of the following documents/submissions:

- Geotechnology Report: Additional Sump and Surface Water Drainage Revision. Specification & Construction Quality Assurance Plan. Report Number 2356r1v1d0523 – dated May 2023.

NRW can now confirm that it is satisfied with the above submissions.
