





For: A discharge of sewage effluent in an emergency

To: Non-tidal river

From: Sewage Pumping Station, Maes Derwydd, Llangefni, Ynys Môn, Gwynedd

This Consent shall not be taken as providing a statutory defence against a charge of pollution in respect of any poisonous, noxious or polluting constituents not specified herein.

THE FOLLOWING REPLACE ALL PREVIOUS CONDITIONS

1. The discharge shall consist only of sewage discharged in an emergency to avoid danger to life or health. An electrical or mechanical breakdown of such severity as to render the pumping station completely inoperable, total failure of the external power supply or total blockage of the rising main shall be considered an emergency. An emergency shall not include station shut-down to facilitate maintenance or refurbishment.
2. The discharge shall be made in the manner and at the place specified as follows:-

Discharging via : A 100mm diameter pipe

Discharging to : Un-named watercourse

At OS Grid Ref : SH 450 757

As shown marked : "Discharge Point" on the attached plan number BM585-01.

3. Adequate facilities, approved in writing by the Authority, shall be provided to enable representative samples of the discharge to be safely and conveniently obtained at any time at the outlet as shown marked "Sampling Point" on the attached plan number BM585-01.
4. The discharge shall only take place via a high level overflow from the wet well of the pumping station. The overflow shall be protected by means of a scum board and bar screen of aperture size not greater than 10mm.
5. The discharge shall only take place when it is not reasonably practicable to dispose of the sewage by other means.
6. In the event of an emergency, a minimum of 6 hours storage capacity shall be available before discharge commences, based on design dry weather sewage flow.
7. Standby equipment shall be provided to enable the immediate resumption of full pumping capacity in the event of a duty equipment failure.
8. The pumping station shall have the capability of automatic restart on restoration of the power supply following power supply failure.
9. A plug-in facility shall be provided for emergency power supply to the station in the event of external power supply failure.
10. The pumping station shall be equipped with an automatic remote alarm system to alert the discharger immediately of any significant station failure.
11. The Authority shall be notified of any discharge as soon as reasonably practicable and in any case within 24 hours.




12. All reasonable practicable steps shall be taken to minimise the duration of the discharge and its polluting effects.
