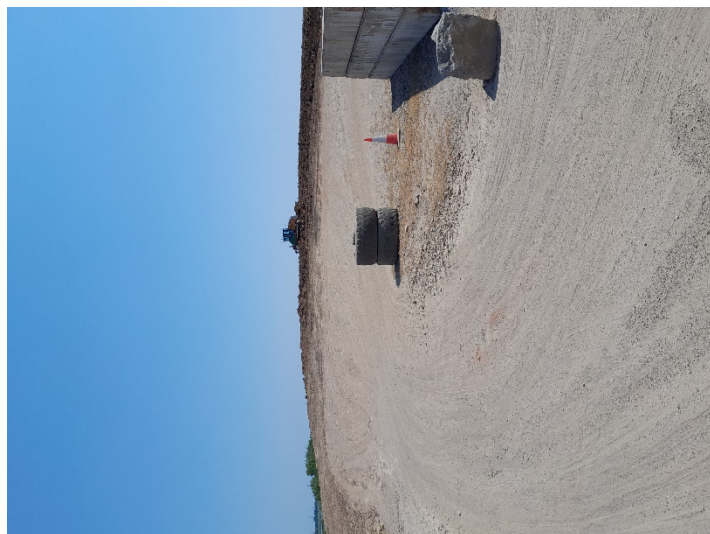

4. Details of our assessment

This report details planned the site visit made on the 8th of June 2023 to Ty Mawr Farm Former Landfill, Newport, permit reference number EPR-AB3891ZU. Officer Chris BURGE attended the Ty Mawr Farm Former Landfill site at St. Brides, Wentlooge, Newport, NP10 8SF for a routine site inspection at 12:30pm and met with Mr. Edward SHERVINGTON (Technically Competent Manager). The weather was dry, Sunny, and warm

At the time of the inspection the site was fully operational. The process is soil is deposited at the site and spread to dry. Any Rogue materials are hand-picked before the material is processed. Photo one shows the bulldozer working to spread the material for the drying process.

SITE INFRASTRUCTURE

During the site inspection there were no apparent issues with the site drainage /infrastructure, which was in good condition. With a large amount of heavy machinery using the site such as JCB's / tractors / HGV's, this should be regularly inspected to ensure that any hardstanding areas remains intact and impermeable.
