4. Details of our assessment

On 15 June 2023 a site inspection was carried out by Natural Resources Wales Officer Sally Wakeford alongside TFS colleagues Mark Rhodes and Jonathan Hawke. We were accompanied on site by Ian Cresswell (Site Manager), John (Operations Manager) and Abby (Environment Manager) and Kevin Connell (TCM).

Discussions were held with the TFS team regarding baled and loose depolluted vehicles being brought to site, initially for export and now being sent to Cardiff. We discussed the mitigation measures in place for any vehicles not fully depolluted on arrival at site. There was no visible evidence from the vehicles on site of any pollution or spills.



At the time of the inspection loose can waste from Swansea Baling Plant was within a bay on site. It was stated there was a 3 day turn around, processing approximately 60tonne per week. It was stated by John that contracts are in place for fly spraying and bags. It is a temporary procedure. Please note that although there were no issues with flies on site at the time, it was noted that there were accumulations of cans within the bay push walls and extending under some vehicle bales. It is recommended that good housekeeping of this area is undertaken to ensure issues do not arise. It was mentioned that the bay may be extended to ensure the can waste does not spill from the front of the bay.



Drains on the dockside were checked and were clear from any debris or waste. TCM is on site weekly for a full day. Included in the checks is the drainage and TCM reports are completed.

It was noted that the containment from the oil and fluid storage has been provided with covers to ensure the containment remains free from rainwater.



During the inspection on 16/01/2023 a non-compliance was noted regarding the drainage on site. The deadline of the action required is the 31/07/2023. This issue was discussed during the inspection and informed that the curb stones, drains and concrete pavement

were all being contracted for completion.
