4. Details of our assessment

This CAR Form is in response to the Improvement Condition IC 41 action in CAR Form NRW 0041954.

Action: Confirm that emergency procedures are in place over the duration of the trial and a hazard review of the trial has been completed.

Valero provided an email response on the 13th June 2023 detailing the following: -

In response to the above action detailed in section 4.0 of CAR_NRW0041954, please be advised of the following:

- *Operating instruction 3-OPS-INS-0006 has been developed and includes routine operator checks to be conducted around the UCO storage tanks and the actions to be taken in the event of a loss of containment. This will supplement our existing site leak response instruction PP-PEM-INS-0093 and On-site emergency plan PP-PEM-INS-0028*
- *A Hazard and Operability study (HAZOP) has been completed (EMOC No. 208050) and, as part of this study, a review of potential loss of containment scenarios and possible impacts on the Waste Water treatment Plant (WWTP) has been considered. We are not anticipating any additional impacts on WWTP performance in the event of a spill or loss of containment to sewer.*

NRW can confirm that the action is closed from CAR Form NRW0041954 as the company have provided relevant information to confirm that emergency procedures are in place and a hazard review of the activity has taken place. NRW may choose to audit/review the activity during the trial.
