### 4. Details of our assessment

NRW Officers arrived, unannounced, to site to carry out a routine inspection on the Environmental Permit to discharge trade effluent to the Alltami Brook. Prior to this Officers checked the brook at the point of discharge. There was no discharge at the time.

During the site visit Officers met various workers and spoke with Sean O'Grady on the phone.

The quarry void had a small amount of water in it. There was no obvious pipe work to suggest any discharges were being made. The surface of the site was very dry.

Officers were unable to work out where or how a discharge is made from site. Section 4 of the permit requires a representative sample point to be accessible and labelled. See action above.

To complete our inspection we have a few questions regarding the discharge permit:

What trade effluent is generally discharged from site?

How often is a discharge made via the permitted sample point?

Is a discharge made manually or automatically?

Do you keep a record of volumes discharged?

Is the trade effluent treated prior to discharge?

How is the discharge point accessed?

Please provide a response to these questions by **12th July 2023**
