4. Details of our assessment

On the 7th of June 2023 NRW officers attended at New Horizon Biofuel and Animal Bedding Co Ltd to conduct a routine unannounced site inspection.

The weather was dry and windy.

Officers were met by the site owner who accompanied officers throughout the inspection.

The site is undergoing some changes which are being discussed separately.

Officers checked both units (9 and 10).

Unit 9

Unit 9 is currently being used for storage of waste that is being processed on the day.

General storage arrangements were discussed with the owner and an updated version of the EMS has been requested to detail current activities taking place on site.

Unit 10.

Unit 10 is currently being used as the main acceptance and storage area for plastic waste. The yard is being kept tidy and accessible. Officers noted there were no fire breaks created along the line where the plastic containers were stored causing a potential risk of pollution in the event of a fire. Please see photos below.

This was discussed with the site owner.

Condition 1.1.1 of the permit states:

The operator shall manage and operate the activities:

(a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints; (...)

The site storage arrangements were not compliant with the Environment management

system (EMS)

As a result of the above permit breach a **category 3** non-compliance score has been issued.

Action: Please ensure the storage of waste is compliant with the EMS. This action has been completed after the inspection.
