3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Unannounced site inspection by Michael Edwards and Sally Wakeford of Natural Resources Wales.

Condition 1.1.3 Any person having duties that are or may be affected by the matters set out in these standard rules shall have convenient access to a copy of them kept at or near the place where those duties are carried out.

During the inspection the operator was unable to provide the documentation on request as required. As discussed during the inspection this has been scored as a **Category 3 Breach** of the above condition.

Action – Ensure that the working plan and permit are available on request as required under the conditions of the permit.

Under condition 1.1.4 The operator shall comply with the requirements of an approved competence scheme.

Action - Please provide evidence that demonstrates compliance with this condition.

Under **condition 2.2.1** Waste shall only be accepted if: (a) it is of a type and quantity listed in table 2.2a and 2.2b below; and (b) it conforms to the description in the documentation supplied by the producer and holder.

During the inspection no non-conforming wastes were identified with wastes were stored inline with **condition 2.3.1** The activities shall be operated using the techniques and in the manner described in **Table 2.3**.

All waste activities were carried out within the boundary of the permit as required under **condition 2.4.1**.

Condition 3.4.1 requires the site manage and operate in accordance with a written fire prevention plan using the current, relevant fire prevention plan guidance.

Action – Please provide a copy of the current Fire Prevention and Mitigation Plan as required under the above condition.

As discussed on site a review of the Annual waste returns would be completed following the inspection of on site operations.

Under **condition 4.2.2** *Within one month of the end of each year, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year.*

Natural Resources Wales is yet to receive the annual waste returns for 2021 and 2022. This has been scored as a **category 4 breach** of the above condition.

Action – Submit all missing waste returns as required under the permit.
