This was an announced visit to discuss ongoing issue of varying the permit due to the bio-filter not in the location as specified by the permit.

Weather conditions throughout the visit were dry and sunny.

Appearance of entry

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

Observations and photos

At the time of the inspection there was no activity on the site and facility doors were closed.

All storage and treatment and composting has been carried out inside the building on an impermeable surface.



The power supply has been connected to the facility. Sion Roberts demonstrated the bio-filter and abatement system working.

The bio-filter has been constructed on the incorrect side of the building. which requires a variation to the existing permit. A variation application was submitted by the operator, however in order to process it NRW wrote to the operation requesting further information. Due to no response from the operator to NRW's request the application was returned.

Please submit a new normal variation application and ensure that the details requested in the correspondence from NRW 19 December 2022 is contained within the new application.

This is a Category 3 permit breach with respect to permit condition 2.1 of criteria A1 Specified by Permit.

No issues were noted relating to noise, odour, litter or pests.

All waste returns have been submitted to Natural Resources Wales. No issues noted

No paperwork was available to be viewed during this visit. Please ensure that all documents relating to the permit are available on-site for inspections.
