4. Details of our assessment

Attended site on the 05/06/2023 at 13:00 and was met by Mr Edgar Griffiths.

Mr Griffiths explained that they no longer dip themselves, but organise for a contractor to carry out the operations via a mobile dipping shower at different locations and dip 450 head of stock. The contractor also supplies the dip (Golden Fleece)

This was then confirmed by Mr Gareth Griffiths and stated that the little amount of spent dip left is then diluted with water and spread using a vacuum tank onto the area stated within the permit.

Records were provided and up to date and in good order.

Accident book also provided.

Discussion regarding CoAPR discussed and concerns addressed.
