4. Details of our assessment

Attended the site on the 05/06/2023 at 10:00

Was met on site by Mr Davies stated that they do not dip every year, but only when required.

Mr Davies then went onto providing details of records with no evidence of paper copies, I asked if paper records were available with the required details and he stated that they were somewhere in the house, and that his son deals with the paperwork and his partner had just had a baby and was away, due to this I used the estimated volumes provided by Mr

Davies on the basis that i would ring up at a later date for this information.

Mr Davies then provided details regarding the storage, He stated that they buy the dip when required and never kept dip on site.

I was then shown the dipping bath set-up and was all in good working order with no concerns of pollution.

I then contacted Mr Davies on the 05/07/2023 for the exact volume details and this was provided over the phone and Mr Davies apologised for the inconvenience. Details provided are compliant with the permit.
