4. Details of our assessment

A routine site inspection was undertaken on Thursday 29th June 2023. Present during the inspection were: David Morgan (Natural Resources Wales) and Richard Morgan (SIMS Metal Management).

No non-compliances with the Environmental Permit were recorded during the inspection. Various aspects of the permitted operation were discussed and the following observations were made:

Incident Recovery (ref: WIRS 2302702)

On 13th April 2023, Natural Resources Wales received a report that SIMS Metal Management was discharging site surface waters from operational areas of the site into the River Neath. The report was accompanied by video footage.

Although there was no evidence of a significant pollution to the watercourse, site surface waters must not be discharged directly off site. No significant impact to the river and/or local environment was recorded.

The investigation into this incident was completed and it was found that this incident occurred due to an employee error. During the inspection on 29th June 2023, records of an internal investigation into the incident were provided for inspection. Investigation and training records were viewed. It was noted that it is the intention of SIMS Metal Management to hold a 'toolbox talk' with staff on site to remind them of their responsibilities with regards to permit compliance and general pollution prevention.

Natural Resources Wales now considers this matter resolved.

Site Drainage

The build up of site surface water in the wharf area appears to have been resolved as infrastructure has been improved with the installation of a new drainage chamber which connects to the site interceptor.

It has been noted that boundary fencing has been installed on the wharf area to clearly define operational areas and the boundary between the adjacent waste operation (Morris & Co).



The area in which the interceptor outlet discharges surface waters was viewed and appeared to be free from any physical signs of contamination (i.e. no visible greases/oils etc.).

Small-Mixed Waste Electrical and Electronic Waste (WEEE) Storage

Following the inspection of 29th June 2023, and prior to the completion of this report, Natural Resources Wales has been notified of a fire incident (Friday 30th June 2023 - 22:45) in the area where small-mixed WEEE is stored.

A new detection system, with automatic fire-fighting capability has been installed and it is encouraging to learn that this system is functioning fully and dealt with the initial incident although Fire Service attendance was still required.

Given that this area of site and waste storage operation has been subject to several fires in recent years, **Natural Resources Wales requests that this activity is reviewed.** Consideration should be given to alternative storage methods (locked skips etc.) in order to prevent rainwater ingress.

Attendance and management of fire incidents requires a commitment of resources by emergency services. You must ensure that all efforts are made to investigate preventative measures.

Natural Resources Wales will now close this individual incident report.

Compliance Assessment

A number of areas of permit compliance were assessed during the inspection. Operations were found to be compliant with the Environmental Permit and no non-compliances were recorded.
