4. Details of our assessment

Unannounced site inspection carried out by Michael Edwards and Sally Wakeford of Natural Resources Wales, accompanied on site by manager Chris Fender.

Under **condition 1.1.3** Any person having duties that are or may be affected by the matters set out in this permit shall have convenient access to a copy of it kept at or near the place where those duties are carried out.

Copies of both the permit and EMS are available on the sites computer system on request as required.

Action – Please provide confirmation of the technically competent managers certification as required under **condition 1.1.4** – ‘*The operator shall comply with the requirements of an approved competence scheme*’.

On site activities were limited to those listed in table S1.1 of the held permit in line with **condition 2.1.1**. *The operator is only authorised to carry out the activities specified in schedule 1 table S1.1 (the “activities”).*

During the inspection of the site, waste level at both the transfer and treatment station and the household waste recycling centre were managed well with all activities carried out within the permit boundary as required under **condition 2.2.1**. with wastes stored in accordance with the conditions set in **table S1.1** of the permit.

With wastes visible on site conforming to **condition 2.3.2 below**;

Waste shall only be accepted if:

- (a) *it is of a type and quantity listed in schedule 2 table(s) S2.1 [, S2.2 etc.]; and*
- (b) *except for household waste accepted from householders, it conforms to the description in the documentation supplied by the producer and holder*

It was noted during the inspection that recent works had been completed on site for an issue relating to the areas power supply which resulted in a portion of the impermeable surface being removed and replaced. During the inspection this area was fenced off to allow the concrete to cure.

Under the conditions of the permit (**3.1.1, 3.3.1 and 3.4.1**) the site is required to ensure that on site activities do not cause pollution outside the boundary of the site.

Natural Resources Wales has not received complaints with regards to the operational noise, odours and pest management.
