4. Details of our assessment

Site visited in response to local concerns about an algal bloom (Phaeocystis) affecting Cardigan Bay and comments regarding the tankering of sewage from Dolgellau sewage treatment works to Tywyn for treatment.

Natural Resources Wales and Dwr Cymru received numerous comments / allegations that the algal was sewage and / or caused by dumping of sewage out to sea from the sewage works.

The weather on the day of the visit was dry and sunny as it had been dry for a couple of weeks. As a consequence the flow through the works was low, and well below levels that would drain to the storm tanks. The storm tanks were empty and clean.

The emergency storm screen at the inlet was inspected. There was no evidence of any discharge via this point to the Tywyn Main Drain.

It was explained verbally during the visit that the emergency discharge had never been used since the site was constructed. However, it's understood that the tidal flap on the emergency discharge, which is located within the NRW Tywyn Main Drain tidal gates, doesn't operate properly. It was explained that this causes a saline intrusion into the emergency chamber during some tides. Can this please be investigated and repaired.

A tanker delivered a load of sewage from Dolgellau STW during the inspection. This was seen to be unloading into the inlet chamber. It was explained that there is a trunk sewer between this point and the inlet screens, so it would not impact on flows through the works. This delivery didn't cause any visual negative impact on the treatment plant and no discharge to the storm tanks.

The visit showed that everything was normal at the works, that the treatment works could easily cope with the additional load caused by the temporary tankering from Dolgellau and that there was nothing to link the site to the algal bloom.
