4. Details of our assessment

A routine inspection was planned for Bethel Construction Limited on Tuesday 6th June 2023.

At the time of the inspection, the site was secure and access onto site could not be made. The site was unmanned but has been assessed as being secure with operations therefore compliant with obligations to main site security.

It is noted that the land has changed ownership and that the new landowner (EBM Ltd) is considering transferring the Environmental Permit (EPR/FB3997TA) into their ownership.
