### **Form S1, Emissions to Sewer, 1<sup>st</sup> July to 31<sup>st</sup> December 2018**

All emissions were within their respective emission limit values.

#### **Production Volumes**

There was an overall decrease in production of more than 20%. Zinc-nickel plated parts increased slightly, but production of zinc plated and anodised parts fell significantly.

#### **WU1, Water Usage, 2018**

The total volume of water used in 2018 was less than in 2017; use per thousand parts was similar to that in the previous year.

#### **R1, Waste Disposal and Recovery, 2018**

Total waste production was less than in 2017 but increased by nearly 20% when compared with production volumes.

It appears that no waste was recovered in 2018.

#### **E1, Energy Usage, 2018**

Overall energy use and thus CO<sub>2</sub> generation were less than in 2017 but increased by almost 20% when production volumes are considered.

This has obviously been a challenging year for TRW, but even so, these results are a little discouraging.
