

Natural Resources Wales permitting decisions

Bespoke permit

We have decided to grant the permit for Arfyn operated by Network Service Facilities LTD.

The application number is PAN-002835

The permit number is EPR/AB3993CC

The permit regulates an existing discharge to ground of package treatment plant effluent; a maximum of 2.5 cubic metres per day, discharged via an infiltration system. The system serves four properties and has been in situ since 1960. The discharge is of domestic nature.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.

Purpose of this document

- shows how all relevant factors have been taken into account
- justifies the specific conditions in the permit other than those in our generic permit template.
