

Natural Resources Wales permitting decisions

Bespoke permit

We have decided to grant the permit for Land at Sommers Lane Farm operated by Mr Colin Williams.

The application number is PAN-001202

The permit number is EPR/AB3397FF

The discharge is for used OP sheep dip from Sommers Lane Farm. A total volume of 2.4 m³ is to be discharged 3 times a year. Each discharge will take place on a appropriately sized area of land and on different part of the allocated field.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.

Purpose of this document
