4. Details of our assessment**Operator Monitoring Assessment**

The OMA focused on the monitoring of emissions to air (periodic and CEMs) from all vents listed in the permit that have emission limit values.

Dow Silicones have shown that quality control for periodic and continuous monitoring are well managed, providing reliable monitoring data. However, the score was slightly lower than previous (71% vs 77%). Several observations are also noted in the full OMA report, which Dow Silicones should consider when reviewing monitoring processes in the future.
