4. Details of our assessment

Perimeter Odour Inspection - Llanddulas Compost Site

A site perimeter odour inspection was conducted at 11:00hrs on the 27th of June 2023 for evidence of

odour from the compost facility.

The areas assessed included; Bron Wern, Pencoed Road, Llindir Road, Pentregwyddel Road and roads in the village of Llysfaen.

No trace of odour was detected in any of the areas assessed on the day.

Further unannounced perimeter odour inspections may be undertaken by NRW throughout the summer.
