4. Details of our assessment**CLAMP REMEDIATION AND ANTI POLLUTION WORKS MONA AD (ANGLESEY ENERGY)
FOLLOW UP INSPECTION**

Following the completion of multiple work streams on site which included the following:

- Resistivity assessment of the ground beneath the clamps
- Installation of leachate sump
- remediation works to seal clamps
- Sampling of upstream and downstream drainage ditch

An inspection was undertaken to assess these works and the status of the remediated site.

- All works in the improvement and remediation programme have now been completed to the satisfaction of NRW.
- The small stream running adjacent to the site is now dry so no sampling can be undertaken at the moment
- The sump draining leachate from under the clamps has proved effective and post sealing should require minimal pumping
- Groundworks are being completed in preparation for a fourth clamp. This should be suitably engineered to ensure no leaks of leachate to ground and adequate apron drainage to the foul system. Any designs should be agreed with NRW before construction begins.
- The surface water drainage pond is of note for the exceptional bio-diversity in both the pond and the immediate surrounding area.

NOTE: A site meeting will be arranged in late July to work through the improvement programme and discuss operational issues going forward
