4. Details of our assessment

On Friday the 23rd of June 2023 Natural Resources Wales officers attended the site.

This was an unannounced, routine inspection.

The site was last visited by Natural Resources Wales (NRW) on 25th of November 2022, the previous inspection is detailed in Compliance Assessment Report: CAR_NRW0040737. No issues were found.

The site was open with operatives on site performing their duties.

On arrival officers met with Charles Whyte, site manager, who accompanied officers during the inspection. Officers were asked to sign in.

Officers were later joined by the yard manager.

Fire prevention measures

Fire prevention measures and the containment of fire water runoff were discussed.

The site benefits from four interceptors, each has capacity of 35.000 litres.

The site has a discharge point and a possibility to block the interceptor completely in an emergency situation (i.e. fire)was discussed. This will be followed up during your next inspection.

The discharge point in inspected on a weekly basis. Officers were provided with photographs of recent checks which are being stored on site.

Vehicle storage

The vehicles are being stored with fire breaks of two meters between petrol/diesel cars and electric vehicles.

The site has also been inspected by FRS compliance manager. Please send the report to your new regulating officer, Ian Thomas. Details below.

Officers walked round the site and inspected the depollution area which looked well organised and tidy.

The batteries and fluids were stored in appropriate, separate containers.

Spill granules and kits were located around the site in case of any leaks or spills.
