4. Details of our assessment

An ad-hoc odour assessment was undertaken by Liz Park outside the permit boundary on Station Road in and around the area of the back gates to the site following a report of an odour emission occurring on 3 June 2023. At the time of the assessment to weather was warm. The wind direction was away from the residential area towards the site. No odour emission was detected.

Liz did notice that there were a number of Corvids on the floor by the wheelie bins pecking at the residue on the ground. This has already been mentioned to Ashley Collins (Senior Manager - Waste and Recycling Services) who informed Liz that steps would be taken to clean up the residue.
