4. Details of our assessment

An unannounced inspection was carried out by David Ellar. Officer was accompanied around the site by the Director of the business Paul Griffiths.

The weather was fine and dry.

The site was fairly quiet in terms of waste and appeared to be well managed. Good segregation of wastes was observed, and no noncompliance's were recorded. The only waste types observed on the yard was a couple of full skips ready to be tipped in shed for sorting and the 'specified' waste (inert waste) in small stockpile. The treatment shed was fairly clear and no build up of waste stockpiles were observed.

Drainage lagoon:

The yard drains into a lagoon at the bottom of the site, the lagoon was dry at time of visit but there was a build up of silt. A recommendation was made that Pendragon should take advantage of the good weather and de-silt the lagoon at their convenience.

Daily ' weekly site inspections:

Several of Pendragons 'Waste Management Site Diary (inspection/audit) forms were viewed. It was clear that site managers do a daily check and the TCM visits the site at least once a week and carries out audit checks. These checks are recorded as are any actions.
