### 4. Details of our assessment

The site was inspected on the 21 June 2023 by David Ellar. The site gate was open, but it

was evident that the site had not been used for the permitted waste operation for some time.

NRW are aware that the site was taken over in August 2020 by Network Rail during the derailment incident but have not had any updates regarding change of use since. The rail incident recovery finished several months ago, and no evidence of Network Rail involvement was now observed at the site. It looked like the main part of the yard was being used for construction purposes, there was plant and machinery stored there and it was clear that it was regularly used. No evidence of a waste operation was seen. No representatives of Browns was on site. Because of this a full inspection was unable to be carried out. **The site was NON-OPERATIONAL**

#### **Technically Competent Manager:**

Leighton Johnson is the TCM and holds WAMITAB MROC1 Level 4 qualification. The qualification was gained 16/03/2021 so evidence of continued competence will be needed early in 2024.

Since the site inspection NRW has been in contact with Leighton Johnson who confirmed that Browns were not undertaking any waste activity there. Leighton was a little unclear who was using it or what Browns plans were with regard to restarting the waste operation there.

**ACTION:** Could Browns please contact NRW to update with future plans of the site and notify NRW before the commencement of any waste operation.

#### **Environmental Management System (EMS):**

It was noted as an action on the last CAR for the site (CAR\_NRW0037917) that the Resume of Environmental Management System Ref BG4 provided during application for the permit stated that "The full environment management system will be presented on receipt of the approved site permit and prior to site operations commencing." This full EMS has not been received by Natural Resources Wales. As no waste operation has been undertaken since the last visit this is again marked as **ACTION ONLY under C" - Management Systems - Permit Condition 1.1.1(a).**

**ACTION:** Before waste operation commences at the site please submit the Full EMS.
