Fourth TSS exceedance of permit level 60mg/l under permit BG0033101. OSM sample analysis result 85 mg/l. Three look-up-table exceedances allowed, so fourth is a permit failure.

No environmental impact measured.

Plant had been undergoing refurbishment works. Operator applied for temporary relaxation of permit in case further exceedances occurred. Relaxation applied from December 2016 and ended 01 May 2017, so relaxation was not active when TSS failure occurred. Fourth exceedance still within rolling-year assessment window.
