This was a permit compliance site inspection carried out by NRW officer Anthony Bruten. A separate Intensive Farm inspection form was completed at the time of the inspection and has been attached to this CAR form.

There were no breached of the permit conditions identified at the time of the inspection. No entry was made to the sheds this was in order to maintain maximum biosecurity. Entry to the sheds was made during other inspections including the Quality assurance inspection carried out on behalf of NRW.

There was some cracks in the concrete outside shed 3 but at this time it is not likely to cause any pollution but will need some maintenance in time.

Other than plan to repair the cracked concrete outside shed 3 there were no non conformances recorded.
