### 4. Details of our assessment

On 19 June 2023 a site visit was conducted at Baglan Bay Works Closed Landfill by Sally Wakeford accompanied by Joanne Fitton of NRW, and various members of Welsh Government and their consultants. The weather was hot and dry.

A site visit was conducted as a familiarisation exercise for the officers and others to discuss the requirements of permit transfer. Access to the main site was provided by WG – the current landowners. The permit is still held by St Modwen Developments Limited.

### **D1- Security – Permit conditions 5 & 7 – Category 3 breach**

At a number of locations along the perimeter of the wider main site there are access routes cut into the fencing. There is also free access to the closed landfill area, with no attempt to prevent it. There is also a well-worn footpath around the perimeter of the site. No site notice board was visible as required by permit condition 5.

Permit condition 5 states:

*A site identification board of durable material and finish shall be displayed at the entrance to the tip site, showing the name and telephone number of person in charge of the site and the name of the Waste Disposal Authority issuing the licence.*

Permit condition 7 states:

*The site must be adequately fenced with gates at the entrance”.*

**ACTION: You must ensure the site is secure and has an adequate identification board.**

It is understood that there is an agreement that the permit will be transferred to Welsh Government as soon as the paperwork can be completed, however there is a requirement on the current operator to ensure the permit conditions are complied with.

There are currently no requirements to undertake any monitoring on the site to ascertain the extent of any environmental impact the site may be having. It is the intention of NRW to undertake an NRW-led variation of the permit to a more modern, up to date permit, with some requirements for monitoring, closure and aftercare.
