4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site, by site employee Rob.

General Management (A1, C1, C2, C3, C4)

Waste was stored appropriately on the yard within designated skips and concrete bays, all waste was on impermeable surface with appropriate drainage in line with **condition 1.1.1** of the permit. No non permitted waste identified during the inspection in accordance with **condition 1.2.1**.

A copy of the permit and working plan was provided on request in the main office in line with **condition 1.4.2**. 'A copy of this licence and the working plan shall be kept available on site for reference when required by all staff carrying out work under the requirements of this licence'. It was agreed during the inspection that copies would also be provided and kept in the cabin above the yard.

Site engineering and infrastructure (B1, B3, B4)

All wastes were stored on impermeable surfaces as required under **condition 2.1.1** of the permit with scheduled cleaning of the site drainage system as required under **condition 2.1.2** to take place to reduce pooling of water in the channels.

Emissions from site (F1, F3, F5)

During the inspection no issues were identified from mud or debris leaving the permit boundary in line with **conditions 4.1.1** and **4.1.2**.

The site was free from dust and particulates as required under **condition 6.1.1** and **6.1.2** and no odours were detected on site during the inspection inline with **condition 6.2.2**. Natural Resources Wales has not received any incident reports concerning dust or odours originating from the sites operations.
