4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of annual emissions monitoring data for NB2. The emissions monitoring was completed by an MCERTS accredited third party test house on 09/06/23. The emissions monitoring results were submitted to Natural Resources Wales (NRW) on 13/06/23 which is within the timescales specified in the permit. All parameters recorded values within the permitted Emission Values (ELVs):

Oxides of nitrogen (NO and NO₂ expressed as NO₂) recorded a value of 134mg/m³ Vs an ELV of 300 mg/m³.

Dust (particulate matter) recorded a value of 11.4mg/nm Vs an ELV of 30mg/Nm.

Carbon Monoxide recorded a value of 16.1mg/Nm Vs an ELV of 225 mg/Nm.

TVOC recorded a value of 13.9mg/Nm Vs an ELV of 30mg/Nm.
