4. Details of our assessment

Routine site inspection conducted on the 29 June 2023 by NRW Senior Waste Regulation Officer Leon Williams and Environment Officer Gareth Siney.

The weather was dry and sunny at the time of the inspection.

Waste operations at this site are currently mothballed following the commencement of insolvency proceedings with the operator, Orthios Feedstock (Anglesey) Limited.

All waste has since been removed from the permitted area.



NRW have not received waste returns from the operator for the periods:

- Quarter 1 2022
- Quarter 2 2022
- Quarter 3 2022
- Quarter 4 2022
- Quarter 1 2023
- Quarter 2 2023

Condition 4.2.2 of the site permit states that "within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted

and removed from it during the previous quarter".

As NRW have not received the waste returns for the periods mentioned above, a CCS Category 4 score has been recorded against permit condition 4.2.2 for this non compliance.

Please ensure that these returns are submitted to NRW no later than the **31 July 2023**.

These returns must be submitted to us even if they are nil returns.
