Biffa Trecatti site visit 22nd May 2019

The purpose of the visit was to go through site plans for an alteration to the existing agreed site drawings. Present were representatives from NRW permitting and geoscience teams. The meeting formed part of pre-application discussions but was also an opportunity to view the current site activities. Thus, this CAR form records the site visit in an official capacity.

During the visit, a site tour was conducted where the viewing platform accessed on foot by the party.

There were a number of seagull's present estimated at 100-200. However, the site has a contracted specialist to disturb the birds. This was seen in action as the specialist set off loud crackers and bangs to distribute the flock which then dispersed.

No areas of operational concern were seen. The wheel wash was seen to be working well. Drivers kept the speed down to site limits, as such dust from the wheels was minimal. The Soil treatment pad was seen to be working well and had several windrows/piles of material in various stages of treatment.

No dust, odour, excessive noise, windblown litter or mis managed waste was seen on the day. No rodents, scavengers or pests were evident.
