4. Details of our assessment

This was a permit inspection by NRW Tony Bruten to ensure compliance with permit conditions.

There were no breaches identified although it was noted that the sign on entry had the old EA Wales and 0800 number so this needs to be updated with name Natural resources Wales and telephone number 03000653000.

There was now a new dirty water collection tank and new concrete which has made containment of water more efficient and as per permit requirements.

The unit is now rearing birds to suit a new rearing method which has reduced the number of birds on site to 65,000.

There is very little mortality rate.

No entry was made to the houses in order to maintain maximum biosecurity. The buildings were all in good order and the site was clean and tidy with no odour, noise or dust issues.
