### **Introductory note**

**This introductory note does not form a part of the notice.**

The following gives notice of the variation and consolidation of an environmental permit.

This Natural Resources Wales initiated variation amends Schedule 3a – Emissions and monitoring - Emissions until 29<sup>th</sup> June 2020. Schedule 3 from the previous permit EPR/EP3230BW/V006 has been reinstated in monitoring section Schedule 3a to correct an error in EPR/EP3230BW/V007 and fix incorrect monitoring standards for some parameters.

In addition, improvement condition IC3 and waste code 10 02 07\* have been added to the permit as Natural Resources Wales have agreed to a trial for the acceptance and use of this waste type. Waste coded 10 02 07\* is solid wastes from gas treatment containing dangerous substances in the process to recover lead. The conditions for the use of waste code 10 02 07\* have been specified in IC3. Only upon written approval from Natural Resources Wales will the waste code 10 02 07\* be valid in the permit.

This variation also adds omitted R&D Codes to Table S1.1 and Directly Associated Activity.

The schedules specify the changes made to the permit.
