Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Q2 2023 (April - June) monitoring results were submitted to NRW on 10 July 2023 in accordance with Condition 4.2.3.

Emission Point A1 Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.2

- No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Total Organic Carbon, Oxides of Nitrogen, Sulphur Dioxide, Nitrous Oxide and Particulates were exceeded during Q2 in accordance with Condition 3.2.2.
- Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.2. An invalid 10minute average was recorded on 25/05/23 due to a technical issue on both duty and standby analysers.
- Air A1 Daily Average, Half Hourly and 10 Minute Averages for 22 and 25 April 2023 reported as non-applicable and 23 to 24 April reported as off. This was as a result of a boiler tube failure.
- The Operator also reported the following on 10 July 2023:
 - Air A1 Daily Average, Half Hourly and 10 Minute Averages for 2 and 4 May 2023 reported as non-applicable and 3 May reported as off, due to a leak in the horizontal pass.
 - The Operator also reported that the plant was off line for part of the day due to an ash discharger blockage on the 12 May 2023.

Residues Bottom Ash and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. Bottom Ash composition for Q1 remained below the 3% TOC limit at 1.17% in accordance with Table S3.4 of the Permit.

Plant operating hours year to date; 3,640 hours were recorded with no periods of abnormal operations.

Waste Returns: Waste returns have been provided for Q2 Waste Received Q1 – 45,862 tonnes Waste Removed Q2 – 13,273 tonnes.

Annual Outage: The Operator informed NRW of the planned annual outage on the 2 June 2023. The outage was planned to commence on 13 June 2023 and scheduled to last 16 days. The Operator confirmed that the annual outage was extended by several days and the plant was back on line 1 July 2023

Schedule Notifications: A Part A Schedule 5 Notification was received on 22 April 2023 relating to a boiler tube failure resulting in one of the boiler pressure relief flaps opening. The boiler was offline until the damaged tube was replaced.

The Part B was submitted on 26 April 2023 confirming the above fault. The boiler tube was replaced and the boiler came back on line at 13:28 on 25 April 2023.

No further actions are required following the Operators internal investigation.
