4. Details of our assessment

Abril Industrial Waxes Ltd

Permit number: BV5858IW

The quarterly reports for the emissions to air and sewer for quarter two (April - June) for 2023 were received by NRW on the 07th of July 2023. All emissions to air and effluent releases to sewer over this period are compliant with the permit.

The reports are accepted.

A copy of Abril's most recent emergency plan (HOGANAS-1530115600-3) was also received. The plan details the hazards posed by on-site inventory and a range of perceivable emergency scenarios, including fires, run away reactions and chemical spills. The emergency plan is detailed, includes site layout schematics, including drainage plans and site operations layout. The specific hazards posed by each scenario have been identified and procedures are in place to manage each emergency scenario should one occur.

It is noted that Abril have identified 'flood' in section '4 – Action criteria' however it's unclear if Abril have any specific procedures detailing any required action during a flooding event. Abril may want to consider reviewing the need for a flood plan / procedures when the emergency plan is next reviewed. Currently the risk of a flood may be low, although data from NRW's flood risk map does show some areas of 'high' risk of flooding from surface water, small water courses and main rivers in the general area of the installation. The effects of climate change may increase the risk of localised flooding events.

The revised emergency plan is accepted.
