The 2023 quarter two (April – June) waste returns were received on the 17th of July 2023. A total of 707.5158 tonnes of waste was received with a total of 727.79 tonnes of waste removed.

All EWC codes are compliant with the permit. The waste returns are accepted.

Six monthly pH probe – S1 report form

The results for the minimum and maximum pH readings for each month from January to June indicate all surface water leaving the installation was compliant. Maximum pH over this period was 8.26 and the minimum was 6.00. The report is accepted.
